#### 1. Call to Order-

### 2. Approval of Previous Minutes

- a. MOTION: Shawn Domingo motion to approve the minutes as submitted.
- b. SECOND: Kilohana Miller.
- c. MOTION: Passed.

### 3. Treasurer's Report

- a. Kilohana Miller sent out the Treasurer's report via email prior to the meeting.
- b. Kilohana will be working with Frank on the upcoming budget.
- c. Kilohana has not made changes to the signing authority on the accounts due to the recent vacancy in the Past President position.
- d. Frank Green suggested that Kilohana add to the bottom of treasurer's report information about grants acquired and when the funds should be expected to be received. Kilohana will add for the next treasurer's report.

# 4. College Goal 808 Updates-Frank

- a. NCAN—awarded PacFAA \$5,000 in grant funds for CG808.
- b. Frank asked Gear Up for an additional \$9,800 in funds for CG808. Gear Up is reviewing the request and should get back to Frank in a week or so.
- c. New Sites and Days
  - i. Up on PacFAA website (under events and training)
  - ii. January 20, 2016, Oahu at Castle, Kapolei, Leilehua, Moanalua and Roosevelt High Schools.

- iii. January 24, 2016, Oahu at Farrington, McKinley, Mililani, Radford, and Waipahu High Schools. On Maui at UH Maui College, on Kauai at Kauai Community College, and on Big Island at UH Hilo.
- iv. January 30, 2016, Big Island at Kealakehe High School.
- v. Trying Saturday for the first time at Kealakehe High School.
- vi. Trying a Wednesday evening for the first time at Castle High School.
- vii. Frank expressed concern about FSA ID's and being able to help students complete FAFSA at these events. Kilohana stated that he plans to have sessions at Financial Aid Nights where students and parents can use a computer lab to apply for their FSA ID's in advance of CG808 events. Shawn mentioned that students can actually complete the FAFSA without the FSA ID signature at the CG808 events but then would have to create the FSA ID at a later date to electronically sign the application. Question about which way is the best way to approach the FSA ID issue, using FAN night as FSA ID creation event so students and parents are ready for CG808 or have students do the FAFSA without the FSA ID at CG808. Dayna Isa stated her college has recruitment specialists who will go out in the community and do FSA ID sessions with students. Jannine Oyama brought up the issue is that parents are the ones who really need the help.

# 5. Financial Aid Nights Updates

- a. Frank stated that an experiment at Castle High School will include FSA ID sessions during FAN
  - i. 2 hour session—1<sup>st</sup> hour presentation, 2<sup>nd</sup> hour create FSA ID.
  - ii. Leilehua High School will have the same type of presentation.
  - iii. FAN presentation is done and booklets are ready to go to the printer. Presenters should have them by the end of October.
- b. Shawn is now the FAN Scheduler
  - i. Shawn presented an up-to-date list of schools who have confirmed for FAN's. He asked the group to give him any updates. Lesli Yogi at P-20 is being sent the updates so she can advertise the events.
- 6. High School Counselor Workshop/PacFAA Fall Training
  - a. Dayna stated the event is October 29<sup>th</sup> at Windward CC
    - i. Bruce Honer will present a federal update webinar in the morning.
    - ii. Frank and Dayna requested from WASFAA to send someone to train on SULA.
    - iii. Frank is working on the presentation for HS Counselors that will include verification, PPY, and the availability of the 17-18 FAFSA on October 1, 2016. He is also gathering information on hot topics from Finaid-L to include in the presentation.
    - iv. Kilohana asked if anyone from the scholarship organizations will be presenting on the outer islands. Frank said he would follow-up.
  - b. Dayna is working on the registration piece for FA workshop and it is almost done. She plans to send out the invites by Monday of next week. There is limited seating for the

financial aid training...maximum 70 people. Kilohana asked if the training is open for non-PacFAA members as well as PacFAA members. Dayna indicated that the training is for members and non-members alike. The PacFAA website should allow non-members to register as well as members.

#### 7. PacFAA Conference

Jannine and Frank attended the event on behalf of PacFAA. They had a table at the event and Frank did a 6 minute presentation. Mark Takai's office gave PacFAA a certificate of appreciation. Frank expressed a concern about PacFAA attending events such as these in the future because the event was essentially a political campaigning event and not for the purpose of providing financial aid assistance and information. Discussion was that PacFAA will decline invitations to events such as these in the future and instead, refer interested parties to the outreach events we offer.
