Common Mistakes

- Using commas or decimals; round to the nearest dollar
- Using the wrong Social Security Number (SSN)
- Does not use the name as it appears on the Social Security Card
- Students think that their parents are their "Legal Guardians"
- Changing the amounts after it was successfully transferred
- Not using the correct marital status; use the marital status as of the day the FAFSA is completed
- Not listing a School Code
- Not signing
